

# NSW Independent Liquor & Gaming Authority

## Meeting Outcomes

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on 19 March 2025 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for 16 April 2025.

ILGA considered the following matters, and the status of each matter is listed below.

**Definitions:**
