The Independent Liquor & Gaming Authority (ILGA) held a board meeting on 16 April 2025 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007, Liquor Act 2007, Gaming Machines Act 2001,* and the *Registered Clubs Act 1976.* The next ILGA board meeting is scheduled for 21 May 2025.

Definitions:
