Meeting Outcomes

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on 18 June 2025 to consider, among other things, applications under the *Gaming and Liquor Administration Act* 2007, *Liquor Act* 2007, *Gaming Machines Act* 2001, and the *Registered Clubs Act* 1976. The next ILGA board meeting is scheduled for 16 July 2025.

An application under the *Gaming and Liquor Administration Act* 2007 was also considered out of session.

Definitions:
