Meeting Outcomes

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on 16 July 2025 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for 20 August 2025.
