Meeting Outcomes

The Independent Liquor & Gaming Authority (the Authority) held a meeting on 15 July 2026 to consider applications and other matters under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next meeting is scheduled for 19 August 2026.

The Authority considered the following matters, and the status of each matter is listed below.

Definitions:
